**THE OBJECTIVE OF THE PADDON RALLY FOUNDATION IS TO FURTHER PROMOTE AND ENCOURAGE MOTORSPORT (IN PARTICULAR RALLYING) AT ALL LEVELS WHILE ULTIMATELY INCREASING COMPETITOR AND VOLUNTEER NUMBERS.**

## **ENTRY CRITERIA FOR CLUB/NOVICE LEVEL FUNDING**

The Foundation acknowledges that Club level motorsport is one of the most important forms of motorsport. It encourages competitors, volunteers and officials into the sport at a relatively low cost, and in a friendly and fun environment. The criteria to be eligible for club level funding is as follows:

- **No age limits.**
- **Open for drivers and co-drivers.**
- **No minimum or maximum event experience.**
- **Must not have competed in any National level motorsport events.**
- **Must, if successful, compete in a minimum of 3 club events per year. A club event is defined as either Motorkhana, Autocross, Sprint, Hillclimb, Bent Sprint or Club Rally.**
- **Must already own or have the use of a vehicle for the event.**
- **Must be a affiliated member of a New Zealand Car Club.**
- **Must have Motorsport New Zealand license (any grade).**

## **WHAT LEVEL OF FUNDING TO APPLY FOR**

On the application forms you will notice that there are different options of support/funding that you can apply for. However it is important to note that within each pool of funds that The Foundation will distribute each year, the key objective will be to help as many people as possible – meaning the more funding you apply for the harder it will be for your application to be accepted. Your application will be considered by The Foundation on the basis of the amount applied for alongside your goals, results and motivation.

### **Some key points for when applying for funding:**

- Be realistic what you are asking for.
- A cost breakdown must be provided of what the funds will be spent on. Please see terms and conditions for what funding will not cover.
- Note that the terms and conditions also impose obligations and consequences if funding is not spent on what was outlined in an application.

## TERMS AND CONDITIONS - APPLICATION

1. An incomplete application form will automatically be rejected.
2. Any application form received after the deadline (noted on the application form) will not be considered.
3. Submission of application forms are to be by email only (details on application form).
4. All information must be accurate and up to date. Where necessary information will be checked and if found to be incorrect, the application may, at the discretion of the Foundation, be rejected.
5. When applying for product support (starter package, car consumables etc) a photo must be supplied to Paddon Foundation to prove that is being used for the intended purpose.
6. Any attempt to sell or pass on any product support or other benefit received will instantly breach your agreement with The Foundation and you will have to immediately return or refund the benefit or value of the product to The Foundation as it may so direct.
7. Any successful applicant who receives financial support must within 12 months from the application being accepted provide a report to The Foundation detailing how the funds have been spent and whether all of the objectives set out in the Application have been achieved.
8. Any financial support must be used by the applicant for what was applied for (i.e as detailed on the application form). Failure to do this will mean that The Foundation will not consider any further applications from that applicant. The Foundation also reserves the right in such circumstances to seek recovery of such funds as and when it so decides.
9. If circumstances change and allocated funds are not going to be spent on what was applied for, or it is proposed that the allocated funds be spent on something other than what was originally applied for, then unless The Foundation has agreed to such change the funds must be repaid immediately.
10. An applicant may make more than one application for assistance however only one application per year will be considered. If an applicant has previously been successful in receiving assistance from The Foundation then that fact will be taken into consideration by The Foundation when considering any further applications.
11. By submitting an application for assistance all applicants ,whether successful or not, acknowledge and accept that they agree to the terms and conditions set out herein and that the same are legally binding on them.
12. Should for any reason there be any change in the proposed use of assistance received from that detailed in the application then in such case the applicant must e-mail The Foundation explaining the situation, the reason for the change, and requesting the approval of The Foundation to apply the assistance for that changed use. A decision will then be made by The Foundation whether to accept or reject the request. The Foundation reserves the right in such situations to require the assistance provided to be refunded or returned to it as the case may be. Should at any time The Foundation become aware that any assistance provided has not been applied for the purpose as applied for the The Foundation reserves the right to seek redress by way of refund or in such other manner as The Foundation sees fit.
13. For the sake of clarity, applications for such things as : Team clothing, food, PR/ride day events will not be considered.

## TERMS AND CONDITIONS - ACCEPTANCE

All applicants whether successful or not will be notified by **email NO LATER THAN 20 February 2017**. Successful applicants are to acknowledge receipt of such advice by email prior to any assistance/funding being provided. No reason as to why an application has been unsuccessful shall be provided nor may an applicant request such information.

1. A media release will be submitted by The Foundation naming all successful applicants. After this time, successful applicants are free to discuss and promote their successful application with Paddon Rally Foundation.
2. Details of all applications, whether or not successful, and any assistance agreed to be provided by The Foundation shall remain confidential to the applicant and The Foundation and neither party may disclose the same to any third party or to the public at large without the express agreement of both parties.
3. The amount of support received from the foundation must be kept strictly confidential and not be reported to media or fellow competitors.
4. Successful applicants will be required to meet guidelines and expectations as pointed out on the application forms. Failure to meet these may result in The Foundation the right to seek redress by way of refund or in such other manner as The Foundation sees fit. If these can not be met for unforseen circumstances, this will be taken into consideration.
5. All successful applicants must display 2 Paddon Rally Foundation decal on their competing vehicle as supplied by The Foundation.
6. All successful applicants must provide The Foundation with at least 1 report before 10 December 2017 with an update of results and events competed in. It is the applicants responsibility to do this and email to [info@paddonfoundation.co.nz](mailto:info@paddonfoundation.co.nz).
7. All successful applicants agree and allow for their name to be published and used by The Foundation provided that all personal information must remain strictly confidential.
8. Successful applicants acknowledge that The Foundation reserves the right from time to time to seek such further information, as it may require, regarding the use to which any assistance provided has been put and further agree to provide such information to The Foundation in a timely manner.

## TIER 2 FOUNDATION MEMBERS

The Foundation will work closer with those applicants that receive continued support, or more substantial support in a given 12 month period.

### **Tier 2 Paddon Rally Foundation applicants are identified by:**

- Having received funding from The Foundation for a minimum 3 years (does not have to be consecutive years)and/or;
- Received more than \$5,000 support from The Foundation in an given 12 month period

Tier 2 applicants acknowledge and agree that they may be required, as a condition of further funding, be required to assist with the promotion of The Foundation as The Foundation may from time to time require.

## BONUS FUNDING

Paddon Rally Foundation encourage and reward any successful applicant that achieves their goals and continues to strive forward at their chosen level. So to help encourage your goals, Paddon Rally Foundation will:

- **Any successful applicant who wins a championship category as noted in the original application, will, subject to available funding and meeting the additional terms and conditions below, receive 50% of the funds granted by The Foundation for that season in order to compete in the same or higher level Championship for the following year.**
- **Any applicant who finishes in the top 3 of their championship category as noted in the original application will, subject to available funding and meeting the additional terms and conditions below, receive 20% of the funds granted by The Foundation for that season in order to compete in the same or higher level championship for the following year.**
- **Any successful applicant that achieves their season goals (as outlined on the application form) will receive \$100 fuel vouchers (conditions as noted below)**

### **Additional Terms and Conditions applying to such additional benefits:**

1. A championship must consist of minimum 4 events in a 12 month period
2. 50% and 20% funds will only be granted if actively competing the following season. Upon achieving the above set results, a small application form will be provided to ensure criteria is met for the following season.
3. For achieving your goal bonus – you must have clearly stated your goal in your original application form and The Foundation must have specifically accepted that goal. If your goal has been so accepted – and you achieve it, you will receive the bonus at the end of the year. There will be no criteria for future participation in motorsport – it's a bonus!
4. In order to qualify for any such bonus funding It is the successful applicant's responsibility to notify the Paddon Rally Foundation of achievement of the noted results above or achieved goals. This must be submitted by email to The Foundation before 10 December 2017 with proof of results to [info@paddonfoundation.co.nz](mailto:info@paddonfoundation.co.nz). The Foundation will then forward an application form to be completed.
5. Payment of bonus funding will be made in conjunction with following year's funding allocation.
6. Bonus funding shall only be available if The Foundation has sufficient funds available for that purpose and whether or not such funds are available shall be at the sole discretion of The Foundation.
